Milestone 1: ACA Renewal Template

Requires the renewal document be completed, signed off and provided to your MarketLink Client team along with the Acknowledgement form of the milestone dates.

□ If you have not yet completed, please contact your MarketLink Client Team to request the most recent Renewal Document

Milestone 2: Loading Offers of Coverage (If applicable)

The loading of coverage offered to populations that are within your organization, but are **not** in the MarketLink system. (Union Groups, Retiree Groups, Cobra participants not administered by MMA and other similar groups.)

- □ If you have completed or this does not apply to you, go to Milestone 3!
- □ If you did not complete, please contact your MarketLink Client Team to see if this is needed

Milestone 3: Load Self Insured Enrollee Data (If applicable)

The loading of enrollments for populations that are covered under self-insured medical plans that may be within your organization, but are **not** in the MarketLink system. (Union Groups, Retiree Groups, Cobra participants not administered by MMA and other similar groups.)

Milestone 4: Approving Medical Offers in MarketLink

Milestone 5: Provide Safe Harbor Data for Pay Rate and W-2

If your Safe Harbor is either W-2, Box 1 or Pay Rate, a data file load is required with the information to support the affordability of your Safe Harbor selection.
